## **By-Laws Revision Proposal**

#### Date submitted May 17, 2016

# -Current Article II, Management:

A. EXECUTIVE BOARD/BOARD OF DIRECTORS Management of the Club shall be the Executive Board, subject to the approval of the membership. The Executive Board shall recommend general policies of the Club. It shall ensure that committees are active and functioning and shall ask for committee reports as necessary. The Executive Board shall supervise all committee chairmen and shall have oversight of Club finances. The Executive Board shall meet at least quarterly and shall manage Club business between regular meetings. The Executive Board shall consist of the President, Vice President, Secretary, and Treasurer. The President shall be chairman of the Executive Board. The Board Of Directors shall consist of (3) three regular Club Members. One BOD Member shall be the immediate Past President of the Club. His term shall run until the time that he/she is replaced by an outgoing President. The remaining two members of the BOD shall be elected in staggered terms of (1) one and (2) two year terms. There will be no time limit or term limit for the BOD Members. No person shall be permitted to serve on the BOD and hold any Officer position at the same time.

## Proposed Article II,

#### **Management:**

A. EXECUTIVE BOARD/BOARD OF DIRECTORS Management of the Club shall be the Executive Board, subject to the approval of the membership. The Executive Board shall recommend general policies of the Club. It shall ensure that committees are active and functioning and shall ask for committee reports as necessary. The Executive Board shall supervise all committee chairmen and shall have oversight of Club finances. The Executive Board shall meet at least quarterly and shall manage Club business between regular meetings. The Executive Board shall consist of the President, Vice President, Secretary, and Treasurer. The President shall be chairman of the Executive Board. The Board Of Directors shall consist of (3) three regular Club Members. One BOD Member shall be the immediate Past President of the Club. His term shall run until the time that he/she is replaced by an outgoing President. In any year where the club's membership of full paid members exceeds 50, the club may by simple motion and approval, add two additional BOD positions to the upcoming year's nomination's slate of officers. The remaining two members of the BOD shall be elected in staggered terms of (1) one and (2) two year terms. There will be no time limit or term limit for the BOD Members. No person shall be permitted to serve on the BOD and hold any Officer position at the same time.

**Reason for change:** The club has demonstrated that in years where membership is lien, BOD meetings do not occur. In lien years trying to fill two non-participating BOD members places an unnecessary burden on the nominating committee.

**Synopsis of Change:** We only need to nominate two additional BOD positions when our club has 50+ full paid members and only if the club members decide to do so.

# ARRL Reaches Agreement with Community Associations Institute on Parity Act 05/28/2016

After 2-1/2 months of intense negotiations, ARRL has reached an agreement with the Community Associations Institute (CAI) — the national association of homeowners associations — concerning amended language of the <u>Amateur Radio Parity Act</u>. This will allow H.R. 1301 to proceed to what is hoped will be passage of the bill in both houses of Congress this year.

"We express support for H.R. 1301, the Amateur Radio Parity Act, as proposed to be amended," the CAI statement said.

ARRL, working with CAI and Congressional staff, agreed on an amended bill that would allow every amateur living in a deed-restricted community the ability to install an effective outdoor antenna.

"We are pleased with the agreement with CAI over new proposed language in the legislation, and thank CAI and the Congressional staffers who helped make this happen," ARRL Hudson Division Director and Legislative Affairs Committee Chairman Mike Lisenco, N2YBB, said. Lisenco stressed that, while the agreement with CAI is significant, there is still much work to be done.

"This agreement with CAI is a big step forward, but getting the Amateur Radio Parity Act signed into law remains a long process. ARRL will still need to call upon the membership to contact their elected officials and ask for their affirmative vote on this bill," he said.

## PUTTING SUMMITS ON THE AIR FOR SAFETY

In what's being called an unprecedented move, nearly two dozen Bengalese mountaineers earned their amateur radio licenses in late May and will soon be using portable radios to provide climber safety, emergency rescues and, if need be, help with searches for missing and fallen climbers.

A report in the Hindustan Times identifies two of the new hams as Dipankar Ghosh and Subrata Dey, both well-known veteran mountaineers. According to Ambarish Nag Biswas, VU2JFA, of the West Bengal Radio Club, the climbers' license are likely the first ever to be issued to any mountaineer. He said that in addition to carrying HF radios in their backpacks with an antenna, the guides will also be outfitted with transmitters that automatically send their position to base camp for tracking purposes in case of an emergency. The West Bengal Club's founder helped train and prepare the climbers for the recent licensing examination in late May.

Dey told the Hindustan Times that the licenses were a long time coming, and that such capability might have saved the life of his friend who collapsed and died on Mount Dhaulagiri in Nepal, the world's seventh-highest peak, just this past 19 May. Earlier that same day, a Nepalese sherpa guide fell to his death from the world's fourth largest peak, Lhotse Face, while fixing ropes for an expedition of soldiers from India.

And just a day later, May 20, Melbourne University lecturer Marisa Strydom died while descending Everest. In her case, it had been feared her body would remain in Nepal but it has now been retrieved and returned to Australia.
